A letter explaining your benefit options was mailed to each member in June. Included with the letter was a yellow card to fill out and return to AIL. This card allowed you to name a beneficiary for this benefit, as well as receive additional no-cost benefits, including a Health Services Discount Card and Child Safe Kits for your children and grandchildren.

The Health Services Discount Card provides your household to save up to 60% on prescriptions, hearing care, vision care/products, and chiropractic care. It also gives you the ability to enroll in an optional discount dental plan to help you save money on various dental services.

The Child Safe Kits help you gather vital data, photos, and fingerprints that would assist authorities in the event the child goes missing or any other emergency.

If you returned the card, a representative of AIL will attempt to contact you by phone or at your home to deliver your AD&D certificate of coverage. If you did not return the card, don't worry—you are still covered for the AD&D benefit. The benefit simply will be paid to your estate, which may be taxable.
